**OFFICIAL CLUB**

**WAIVER/RELEASE, REQUIRED FOR PARTICIPATION IN CLUB ACTIVITIES:**

Member expressly recognizes, understands and agrees to all of the following:

**[1] Assumption of Risks.** Participation in TEAM Adrenalin EPC Multisport Club ("Club") functions including, but not limited to, Swimming, Bicycling, Running and Triathlon (each a "Club Activity", collectively "Club Activities") presents serious risks to Member including, but not limited to, head or other injuries, loss of sight, broken bones, brain damage, paralysis and death. Member is responsible for evaluating the risks Member may face and is responsible for Member's actions while participating in any Club Activity.

Member is solely responsible for: (a) Member's proper preparation and safety while participating in any Club Activity; (b) providing, utilizing and maintaining any equipment necessary for the safe participation in any Club Activity; and (c) wearing a properly functioning SNELL or ANSI approved helmet while participating in any Club Activity which includes Bicycling.

The Club assumes no responsibility for any liability, damage or injury that may be caused by Member's participation in any Club Activity, or for any liability, damage or injury caused by the intentional or negligent acts or omissions of any other participant in any Club Activity, or by any other person.

**[2] Indemnification and Hold Harmless.** Member shall indemnify, defend and hold harmless the Club, Adrenalin Cycles, Endurance Performance Coaching, Inc., their officers, directors, shareholders, employees, agents, and volunteers from any action, claim, or demand, including reasonable attorneys' fees and/or any other associated costs, that Member and Member's heirs and legal representatives, have or may have for any and all personal or property injuries Member may sustain, regardless of cause or fault, as a result of Member's voluntary decision to directly or indirectly participate in any Club Activity.

**[3] Release of Claims.** Member and Member's heirs, legal representatives, employers, insurers, and attorneys, hereby release and discharge the Club, its officers, directors, shareholders, employees, agents, and volunteers ("Released Parties") from any and all claims which may arise from any cause whatsoever, including any negligent act or omission by the Released Parties. Member further releases and

discharges the Released Parties from liability for any accident, illness, injury, loss or damage to personal property, or any other consequences arising or resulting directly or indirectly from Member's participation in any Club Activity. Released Parties assume no responsibility for any liability, damage, or injury that may be caused by Member's negligent or intentional acts or omissions committed prior to, during, or after participation in Club Activities, or for any liability, damage, or injury caused by the intentional or negligent acts or omissions of any other participant or in the Club Activities, or by any other person.

**[4] Physical Condition and Insurance.** Member is physically capable of participating in Club Activities and has no known health restrictions that might jeopardize Member's safety or health or the safety or health of other participants in Club Activities.

**[5] Severability.** Should any provision of this Agreement be held to be invalid, the remainder shall remain in full force and effect. To that end, this Agreement is severable.

**[6] Governing Law and Venue.** This Agreement shall be construed in accordance with, and governed by, the laws of the State of Colorado.

**[7] Construction and Scope of Agreement.** The language of this Agreement shall be construed as a whole, according to its fair meaning, and not strictly for or against any party. This Agreement is the only, sole, entire, and complete agreement of the parties relating in any way to the subject matter hereof. No statements, promises, or representations have been made by any party to any other, or relied upon, and no consideration has been offered or promised, other than as may be expressly provided herein. This Agreement supersedes any earlier written or oral understandings or agreements between the parties.
